

TRUTH IN SAVINGS DISCLOSURES

April 10, 2019

This disclosure contains information about terms, fees, and interest rates for some of the accounts we offer.

REGULAR SAVINGS

Statement savings account.

Rate Information: This Account is an interest bearing account. The interest rate and annual percentage yield are included in the Rate Chart. The interest rate and annual percentage yield may change. At our discretion, we may change the interest rate on the account weekly. Interest begins to accrue on the business day you deposit noncash items (for example, checks). Interest will be compounded daily and will be credited to the account quarterly.

Balance Information: We use the daily balance method to calculate the interest on the account. This method applies a daily periodic rate to the principal in the account each day.

Limitations: You must deposit \$100.00 to open this account. Federal law requires that an account holder may make no more than six(6) preauthorized transfers during any one(1) calendar month, statement cycle or similar period. Such transfers may be made during any one period, by check, draft, debit card, or other instrument payable to a third party.

Account Fees: A monthly service charge of \$2.00 will be imposed each statement cycle the balance in the account falls below \$200.00 during the statement cycle period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

PREFERRED PLUS-NOW

Unlimited transaction interest bearing checking account.

Rate Information: This Account is an interest bearing account. The interest rate and annual percentage yield are included in the Rate Chart. The interest rate and annual percentage yield may change. At our discretion, we may change the interest rate on the account weekly. Interest begins to accrue no later than the business day we receive credit for the deposit of noncash items (for example, checks). Interest will be compounded monthly and will be credited to the account monthly.

Balance Information: We use the average daily balance method to calculate interest on your account. This method applies a periodic rate to the average daily balance in the account for the period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

Limitations: You must deposit \$100.00 to open this account.

Account Fees: With Check Safekeeping, a monthly service charge of \$9.00 will be imposed if the minimum daily balance falls below \$1,000.00 during the statement cycle period. Without Check Safekeeping, a monthly service charge of \$12.00 will be imposed if the minimum daily balance falls below \$1,000.00 during the statement cycle period. Check order charges may vary. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

MONEY MARKET - PERSONAL

Limited transaction interest bearing checking.

Rate Information: This Account is an interest bearing account. The interest rate and annual percentage yield will depend upon the average daily balance in the account as shown on the Rate Chart. The interest rate and annual percentage yield may change. At our discretion, we may change the interest rate on the account weekly. Interest begins to accrue no later than the business day we receive credit for the deposit of noncash items (for example, checks). Interest will be compounded monthly and will be credited to the account monthly.

Balance Information: We use the average daily balance method to calculate interest on your account. This method applies a periodic rate to the average daily balance in the account for the period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

Limitations: You must deposit \$1,000.00 to open this account. Federal law requires that an account holder may make no more than six (6) preauthorized transfers during any one (1) calendar month, statement cycle or similar period. Such transfers may be made during any one period, by check, draft, debit card, or other instrument payable to a third party.

Account Fees: A monthly service charge of \$10.00 will be imposed every statement cycle period if the minimum daily balance during the cycle period falls below \$1,000.00. Check order charges may vary. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

GOLDEN VALUE NOW

Unlimited transaction interest bearing checking account. Free "Golden Value" checks. No fee on cashier's checks.

Rate Information: This Account is an interest bearing account. The interest rate and annual percentage yield are included in the Rate Chart. The interest rate and annual percentage yield may change. At our discretion, we may change the interest rate on the account weekly. Interest begins to accrue no later than the business day we receive credit for the deposit of noncash items (for example, checks). Interest will be compounded monthly and will be credited to the account monthly.

Balance Information: We use the average daily balance method to calculate interest on your account. This method applies a periodic rate to the average daily balance in the account for the period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

Limitations: You must deposit \$1,000.00 to open this account.

Account Fees: With Check Safekeeping, a monthly service charge of \$0.00 will be imposed each statement cycle period. Without Check Safekeeping, a monthly service charge of \$4.00 will be imposed if the minimum daily balance falls below \$1,000.00 during the statement cycle period. Check order charges may vary. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period.

CD 7 - 29 DAYS

Rate Information: This Account is an interest bearing account. The interest rate and annual percentage yield will depend upon the daily balance

in the account as shown on the Rate Chart. The interest rate and annual percentage yield will not change for the term of the account. The interest rate will be in effect for 7 Days - 29 Days. Interest begins to accrue on the business day you deposit noncash items (for example, checks). Interest will be compounded monthly and will be credited monthly. We will mail the interest in a check to you or deposit the interest in an account that you designate. The annual percentage yield assumes interest will remain on deposit until maturity. A withdrawal will reduce earnings.

We will mail the interest in a check to you or deposit the interest in an account that you designate. The annual percentage yield assumes interest will remain on deposit until maturity. A withdrawal will reduce earnings.

We will mail the interest in a check to you or deposit the interest in an account that you designate. The annual percentage yield assumes interest will remain on deposit until maturity. A withdrawal will reduce earnings.

Balance Information: We use the daily balance method to calculate the interest on the account. This method applies a daily periodic rate to the principal in the account each day. You must maintain a minimum balance of \$1,000.00 in the account each day to obtain the disclosed annual percentage yield.

in the account as shown on the Rate Chart. The interest rate and annual percentage yield will not change for the term of the account. The interest rate will be in effect for 60 Months and Over. Interest begins to accrue on the business day you deposit noncash items (for example, checks). Interest will be compounded monthly and will be credited monthly. We will mail the interest in a check to you or deposit the interest in an account that you designate. The annual percentage yield assumes interest will remain on deposit until maturity. A withdrawal will reduce earnings.

Balance Information: We use the daily balance method to calculate the interest on the account. This method applies a daily periodic rate to the principal in the account each day. You must maintain a minimum balance of \$1,000.00 in the account each day to obtain the disclosed annual percentage yield.

Limitations: You must deposit \$1,000.00 to open this account. You may not make additional deposits into this account. You may not make withdrawals from your account until the maturity date.

Time Account Information: Your account will mature in 60 Months and Over. If you withdraw any of the principal before the maturity date, we may impose a penalty of 90 Days simple interest. If you do not withdraw the funds, each renewal term will be for an identical period of time as the original term.
